Q: What solutions will you support for school challenges, including disorderly classrooms, a high dropout rate, truancy, and a lack of parental involvement?

A: Disorderly Classrooms: Focus on solutions that address root causes of behavior issues such as specialized trauma training for teachers. High Dropout Rate & Truancy: Expand mentoring opportunities and work with community organizations that provide wrap around services. Advocate for creative programs, activities and classes that motivate children to stay in school. Lack of Parental Involvement: Work with community organizations to educate families about how and why they can get involved.

## Q: What solutions do you propose for improving the physical condition of Richmond's public schools?

A: With a negative 2017 Capital Improvement Budget variance of 82% (~\$50M requested and \$9M approved) it is clear that there is much work to be done to advocate for capital improvement dollars. I will use my financial acumen to understand the School Board's budgetary constraints, school capacity issues and financially prudent debt strategies to work with City Council and Mayor's office to implement a strategic building plan that addresses our long term needs.

Q: What would you propose to improve and expand early childhood education programs?

A: Expanding quality early childhood education programs will be a top priority. I will advocate for allocating more budget dollars to expanding pre-k in the City of Richmond. I will also work to identify additional funding sources to accelerate the expansion of pre-k including state and federal grant money. Lastly this is a conversation that needs to happen at the state/federal level to advocate for universal pre-k.

For example, technology companies providing a sponsored technology program/wing or advertising on the school buses. In addition, the school board needs to establish a clear long-term vision on the future of all school buildings.

### Q: What would you propose to improve and expand early childhood education programs?

A: Step one is having the capacity for all children to attend an early childhood education program. Once we are able to service all students, then we need to assess the facilities and effectiveness of the programs to continue improving their quality.

# Q: What solutions will you support for school challenges, including disorderly classrooms, a high dropout rate, truancy, and a lack of parental involvement?

A: I believe our district and the School Board must adopt and implement more holistic trauma and socially informed approaches such as: restorative justice models, community court models, as implemented at Community High School, and meeting the community where they are by hosting monthly or quarterly town halls and listening sessions, to increase community and parent involvement and reduce behavior issues and truancy. The method by which we evaluate "drop-outs" is flawed and need to be reevaluated.

A: I support implementing Option 5 of the Facilities Task Force Plan, to help alleviate overcrowding in the Southern part of the district, and combing schools in the Northern and Eastern portions of the District.

### Q: What would you propose to improve and expand early childhood education programs?

A: I would propose using spaces in schools that have been redeveloped within the past year and are not being effectively utilized, such as the community center attached to Huguenot High School. I would also strongly consider evaluating space that may be underutilized or can be re-appropriated for classroom space in our specialty schools. Additionally, I wold work within the administration to implement a central hub registration system to make enrollment more efficient and expansive.

## Q: What is your position on guns in public schools? (Teachers/Administrators/Law Enforcement/ Visitors)?

A: I believe that only properly trained and certified Law Enforcement Officials should be permitted to carry guns in or around public school grounds.

#### Q: What other priorities for the schools do you have?

Option 5 also contains the low cost method of rezoning in order to balance the growth on Richmond's south side schools. ## Q: What solutions will you support for school challenges, including disorderly classrooms, a high dropout rate, truancy, and a lack of parental involvement?

A: Although many of our schools have challenges, our children have an innate ability to learn and be successful. I suggest professional development in classroom management and mentors in the schools to assist teachers with 0 to 3 years of experience, in-school suspension programs with a curriculum that is aligned to instruction, enhanced literacy programs, career tech programs in the individual schools, stronger PTA's, more organized parent visits in schools, athletics, and school uniforms.

# Q: What solutions do you propose for improving the physical condition of Richmond's public schools?

A: We have a phenomenal Option 5 facilities plan that incorporates rezoning, new construction and school closure. I propose that we demolish Elkhardt Middle School, and start new construction of Elkhardt/Thompson. We can also replace windows, upgrade our pipes in our buildings that contribute to mold due to heavy condensation, and replace floors to reduce pests and rodents. We should also address many of our building roofs and wiring to enhance technology.

#### Q: What would you propose to improve and expand early childhood education programs?

A: I believe that communication is key to improving and expanding early childhood educational programs. Providing parents a facility close to home will give them better choices and opportunities to participate. Outreach is also necessary through partnering with local daycares and agencies like Parks and Recreation, Boys and Girls Clubs and YWCA's. ## Q: What solutions will you support for school challenges, including disorderly classrooms, a high dropout rate, truancy, and a lack of parental involvement?

A: RPS challenges stem from a variety of socio-economic factors that require strategic, multifaceted solutions including: 1) integrating a trauma informed approach to our teaching and discipline processes; 2) implementing creative incentives that encourage greater parent engagement in schools; 3) broadening the curriculum we offer students to include more STEM courses as well as technical and vocational training options; and implementing truancy prevention best practice methodologies.

## Q: What solutions do you propose for improving the physical condition of Richmond's public schools?

A: We must ensure sufficient funding is allocated so that ALL our schools are structurally safe and offer healthy environments in which our children can to learn. We must devote the resources necessary to improve facilities, starting with the most critical issues and then addressing all needed updates with a sense of urgency. We need to make a long term plan so that future facility needs are anticipated and may be addressed before they get to a point of crisis.

#### Q: What would you propose to improve and expand early childhood education programs?

A: Early childhood programs should be made available to every child entering the RPS system. We should expand both Headstart and the Virginia Preschool Initiative Programs by funding a sufficient number of classes at every school. This investment ensures all RPS students get the strong and early educational start they need. Studies have proven that an investment in early childhood education programs is an investment in a brighter future – especially for vulnerable children.
